If a town lot, give parcel number, lot number, and town in which it is located. Send STAMPED SELF-ADDRESSED ENVELOPE FOR REPLY. Tax statements are mailed semi-annually to address on records.

PAYMENTS BY MAIL: Stubs MUST be returned. Cancelled check is proof of payment. If you desire a receipt, return ENTIRE Statement with STAMP SELF-ADDRESSED ENVELOPE.
