If a town lot, give parcel number, lot number and town in which it is located. Send **STAMPED SELF-ADDRESSED ENVELOPE FOR REPLY**. Tax statements are mailed semi-annual to address on record.

**PAYMENTS BY MAIL:** Stubs MUST be returned. Canceled check is proof of payment. If you desire a receipt, return ENTIRE statement with STAMPED SELF-ADDRESSED ENVELOPE.
